In consideration of the Co-operative's acceptance of my/our application I/we hereby agree and undertake to pay all accounts due to the Co-operative by the last business day of each calendar month in which the account is issued to me/us and that such accounts due are security interests in accordance with the Personal Property Securities Act. I/We acknowledge and agree that in the event of me/us failing to pay my/our account by each monthly date for payment the Co-operative may institute recovery proceedings without notice for the full balance outstanding as at the date of commencement of recovery proceedings and interest (if any) accrued thereon, and to charge interest at the rate of 15% per annum or at such higher rate as may be set by the co-operative from time to time not exceeding 2% above the interest rate charge by the Co-operative's bankers on overdrawn trading accounts exceeding \$100,000.00 for each and every day during which my/our account remains unpaid together with any legal or other debt collection expenses incurred by the Co-operative in instituting recovery proceedings or taking any other action to recover amounts not paid by me/us.

I/We agree and consent to the Co-operative registering on the Personal Property Securities Register any security interest it owns in accounts due and payable by me/us.

I/We acknowledge that should I/we fail to pay any account issued to me/us in accordance with the Co-operative's terms of trade and the Co-operative elects to commence recovery proceedings against me/us, then the Co-operative shall be entitled to recover payment for all outstanding monthly balances due by me/us to the Co-operative together with payment for any subsequent goods or services ordered by me/us from the date of issue of the co-operative's last monthly account addressed to me/us up to and including the date upon which recovery proceedings are commenced by the Co-operative.

I/We acknowledge that I/we will be liable to pay all accounts to the Co-operative in the above manner notwithstanding that any item debited thereon may result from or arise out of the unauthorised use of my/our personalised member number or any other order code which may be issued by the Co-operative from time to time.

The relationship between the parties created on acceptance of this application by the Co-operative shall be governed by the laws of the State of Western Australia which shall apply to any dispute that shall be resolved under the jurisdiction of the Courts of Western Australia.

As a condition of acceptance of this Application the Co-operative may in its absolute discretion require one or more of the directors and/or shareholders of a corporate applicant to personally guarantee performance of the corporate applicant's obligations to the Co-operative from time to time.
